I understand and agree to all of the following:

1. Set up is on Saturday morning (Nov 3) beginning at 6 am. All artists agree to cart from parking lot which is close to the artist booth space. Show begins each day at 10 am. All artists must complete their set-up prior to 10 am Saturday. The show ends each day at 4pm. Do not break down until after that time. All tents must be adequately weighted and/or staked (no exceptions/fire dept will inspect). All tents must be white in color. Security will be provided on Saturday night from 4pm until Sunday morning at 7am. Artists are responsible for securing their booth before leaving on Saturday night. The City of La Quinta and the La Quinta Art Association do not guarantee any loss of inventory or any damage that could occur during the event.
2. Deadline to apply to this event is August 8th, 2018.
3. Notification of acceptance to artist will be no later than August 15th, 2018.
4. La Quinta Park has a no smoking policy. There is a no smoking at event.
5. La Quinta Art Association may use artist's name, images, and any other contact information in the promotion of the event.
6. Artist is responsible for leaving a clean space when vacating the premises.
7. Artist agrees that additional set-up rules will be provided closer to event date.
8. Artist will provide a copy of a La Quinta Business License 30 days in advance of event.

Indemnification Statement:

I, the participant , fully understand that my participation in this event exposes me to the risk of personal injury, death or property damage. I hereby acknowledge that I am voluntarily participating in this event and agree to assume any such risks.

I hereby release, discharge and agree not to sue the City of la Quinta or the La Quinta Art Association for any injury, death to or loss of personal property arising out of, or in connection with, my participation in the event from whatever cause, including the active or passive negligence of the City of La Quinta or the La Quinta Art Association or any other participant in the event.
